

family prayer. First-year parents agree to complete all new parent orientation activities including: new parent orientation, workshops and Principle Approach® seminars.

6. Field Studies: The parent/guardian hereby gives blanket authorization for the child to participate in field studies arranged by the school. StoneBridge activities are supervised by qualified persons and reasonable care is taken to prevent accidents; however, the parent/guardian recognizes that the school cannot be responsible for personal injury and therefore agrees to hold StoneBridge harmless and indemnify the school in connection with any accident, including, but not limited to, injury inflicted by or upon the student.

7. Guarantee: The parent/guardian understands that every student is unique and that the school cannot guarantee any specific level of progress.

8. Performance: Failure by the school to require performance of any term herein shall not affect its right to enforce same, nor shall it constitute a waiver of any succeeding breach. Should any clause of this agreement be found unenforceable, it shall not affect the enforceability of the remaining provisions.

9. Transferability: This agreement is neither assignable nor transferable, and shall be governed by the laws of the Commonwealth of Virginia.

10. Transition: This re-enrollment contract may be given in advance of the completion of the re-enrollment process required for rising 6th and 9th graders. It is understood that this contract is contingent upon the successful completion of that process.

11. Errors in calculations: The parent/guardian agrees that in the event the tuition amount has been calculated incorrectly, StoneBridge School may notify the parent/guardian of the miscalculation in writing, and the parent/guardian agrees to make the correct payment amounts in accordance with the terms of the agreement for both amounts already due and payable and all future amounts.

12. Financial Aid contingency: The parent/guardian and StoneBridge School concur that this agreement is made contingent upon the parent/guardian's receipt of financial aid. Parent/Guardian shall apply for such aid no later than **April 13, 2012**, and shall take all steps necessary to participate and cooperate in the application process. Parent/Guardian shall have the option to terminate this agreement based upon the denial of financial aid, through no fault of the parent/guardian, provided the parent/guardian notifies StoneBridge School in writing of the election to terminate this agreement no later than June 1, 2012. In any event, this contingency shall be deemed satisfied and removed as of June 15, 2012, and this agreement shall be in full force and effect.

13. This Contingency Applies only to StoneBridge School Employees: The parent/guardian and StoneBridge School agree that this agreement is made contingent upon the StoneBridge School employment of _____ [parent/guardian] for the academic year 2012-13. Should _____ [parent/guardian] not be offered SBS employment, the parent/guardian shall notify SBS in writing of his/her election to terminate this agreement prior to July 1, 2012. In any event, this contingency shall be deemed satisfied and removed as of September 1, 2012.

14. Photography Authorization and Release: With my signature below, I authorize StoneBridge School to use images, photographs, student art work, crafts, poems, or other creations by my child for promotional materials and/or the school's website. I release StoneBridge School from all liability in connection with such use.
